FROM THE DESK OF MAYOR NIWINSKI

Since the nationwide mortgage crisis in 2008, the Village of Sloan, similar to every municipality in Erie County, has been dealing with “zombie” properties- vacant homes that are tied up in lengthy bank foreclosures. Working closely with the Buffalo and Erie Land Bank (BENLIC), we have completely refurbished a home on Atlantic Avenue and it has been sold to a new family. BENLIC is currently working on another abandoned home on Wagner, which should be ready for sale this summer. Both of these properties were vacant in excess of four years. BENLIC has also assisted the Village financially in demolishing two other buildings, on William and Reiman Streets. On July 12th, the Board will be holding a public hearing on the demolition of 83 Roland Street. After the property is razed and BENLIC has completed a judicial foreclosure, the lot will be sold to a neighbor. Although we must follow our procedure outlined in Vil-

lage Code for condemned properties, BENLIC will reimburse us for all affiliated costs. This summer, the Board will be reviewing our vacant homes and making recommendations to BENLIC for future rehabilitation and/or demolitions.

As reported in the Spring issue of the Connection, we are progressing on our Order on Consent mandates from the Department of Environmental Conservation. The Order mandates necessary repairs to our sewer system to prevent Inflow and Infiltration (I&I). The Village has submitted a revised Corrective Action Plan (CAP) as required and are pending final approval by the DEC. Over this summer and fall, our engineers will be completing smoke and dye testing throughout the Village to determine areas in need of repairs, and illegal sewer connections. Illegal hookups are determined to be any sanitary being disposed of into the storm system, or storm connected to the sanitary system. On page two of the Connection, we have developed

a Q&A for residents to better understand the Order and what we can all do to reduce I&I.

As summer approaches, I hope to see all of you at one of our upcoming concerts in Griffith Park or the family picnic on August 21st.

ORDER ON CONSENT Q&A.....

Q: What is a sanitary sewer?

A. A sanitary sewer transports wastewater from your home/business to a wastewater treatment plant. Each property is connected by a lateral pipe into the main sanitary system. Owners are responsible for their own laterals. The Village is responsible for all main sanitary pipes.

Q: What is a storm sewer?

A. A storm sewer transports water that is generated from rain, ground water or snow melt and flows, via a system of pipes and culverts, directly into streams/rivers that carry it untreated into Lake Erie.

Q: What is Inflow & Infiltration (I&I)?

A. **INFLOW** occurs when rainwater is misdirected into the sanitary instead of storm system. The remedy for **INFLOW** is to remove improper connections to the sanitary system.

INFILTRATION occurs when groundwater seeps into the sanitary system through cracks or leaks in underground pipes. Cracks or leaks are caused by age-related deterioration. Most sewer infrastructure in our community is in excess of seventy years old.

Q: What problem do I&I cause?

A. I&I are a cause of sanitary sewer overflows and backups that may release raw sewage into your home and pollute Lake Erie. Overflow occurrences put public health at risk and violates state and federal environmental laws. There exists the additional costs to taxpayers of when clear storm water enters the sanitary system and is unnecessarily treated at a wastewater treatment plant.

Q: What can our community do to reduce I&I?

A. Residents can check their own homes or businesses for improper connections and make any necessary repairs. Both your sump pump and downspouts must be draining onto your own lawn area, and not connected to the sanitary system. Upon sale of a property, the Village now requires a storm drainage inspection be completed by the Code Enforcement Officer for improper connections.

RECYCLING ALL YEAR ROUND - DID YOU KNOW.....

Over 75% of what we throw away could be recycled. Please help protect the environment and learn what items are acceptable or not, together our efforts will make a difference.

ACCEPTABLE: Cardboard-can be cut into flat sections and placed next to tote, Paper bags, pizza boxes-wax paper sheet must be removed, junk mail envelopes, flyers, brochures, postcards, paper board not wax coated-cereal, cracker, cookie

boxes, newspapers with no rubber bands, strings, or bags, magazines, catalogs, paper, phone books, empty steel/tin cans, empty clear bottles/jars, empty plastic jugs, bottles, household plastic containers like mayo, salad dressing, margarine tubs, mustard, ketchup, kitchen cookware, metal pots, pans, tins, utensils, large rigid plastic items like: lawn chairs, kitty litter tubs, 5 gallon plastic buckets, children's large plastic toys.

UNACCEPTABLE: Styrofoam containers or packaging, wax coated juice/milk containers, household garbage, paint cans, medical waste, batteries, flammable liquids, household cleaners, wood items, concrete, garden hose or rubber items, electrical cords, tires, branches, yard waste, grass clippings, light bulbs, dishes or ceramics, plastic grocery store bags, pool liners, tarps, covers, propane tanks, plate glass, mirrors.

DOOR - TO - DOOR SOLICITORS

Are you annoyed when door-to-door solicitors come knocking? If the answer is yes, please call Village Hall and request that your address be added to the "No Solicitors" list we maintain. This list is provided to every person who is granted a solicitation

permit from the Village. You have every right to ask a solicitor for proof of a Sloan issued permit. If they are unable to provide one, contact Cheektowaga Police Dept at 686-3501. Do not be pressured into providing copies of your utility bills

to anyone under the pretense that they will be disconnected. Never let a solicitor in your house and if you feel you are being pressured or they will not leave, call 911 immediately. The only exception to the permit requirements is for religious organizations.
